Vision

The All-Russian MS Society is the key public organization among Russian counterparts that represent the interests of people with MS and their family members.

The All-Russian MS Society puts forward, accumulates and guides activities of the general public, government and professional community towards improving the quality of life of people with MS.



Objectives

- 1. To improve the quality of medical and social assistance for people affected by MS
- 2. To ensure the legal safety of people with MS through legislation development and taking measures to control the execution of it with the help of authorities and profile institutions
- 3. To organize interaction with manufacturing companies in order to promote the production and deliveries of high-effective pharmaceuticals, medical equipment, and rehabilitation facilities
- 4. To promote training for medical profession in the area of MS
- 5. To create a positive attitude among general public, raise MS awareness and inform about ways to cope with the problem
- 6. To activate and consolidate efforts of social partners in fighting MS



Principles

- 1. We care for the health and well-being of each person in Russia affected by MS
- 2. We respect the right of people with multiple sclerosis to make decisions. We do not intervene in the private life of a patient and his/her family without authority
- 3. We speak out about the real needs of people affected by MS
- 4. We are a link between the civil society and authorities, between a human and an official. In the capacity of a go-between, we do the monitoring of all social partners' activities with a view to that they meet the norms of human rights
- 5. We are available to participate in social programmes that contribute to the work of power authorities and social partners in the implementation of rights of people with MS
- 6. We respect the system of values and the expertise of physicians, business representatives and authority bodies as well as of our other partners
- 7. We use all possible means to promote healthy lifestyle, make every effort to reveal an example to follow in abiding by social and professional ethical norms
- 8. We support developments towards improving the quality of medical services and the effectiveness of diagnostic facilities and therapy
- We contribute to developing the system of healthcare and social medicine

Expansion into regions

- 2002 Establishing the Polyfunctional Neurocentre for disabled persons with MS in Samara
- Engaging regional branches in the work of the Public Committees at governors' offices and the health ministries, in the activities of the health committees at the legislative assemblies in 5 regions of the Russian Federation (RF)
- 2003 Development of the discussion and passing of target regional programmes to support disabled people with MS in 12 regions of Russia
- 2003 Conducting investigation of possibilities to adopt Regional Target Programmes to support disabled people with MS in 28 regions of the RF

Partnership with authorities

- 2003 Permanent cooperation of the All-Russian MS Society with the Healthcare Committee at the State Duma (Parliament) of the Russian Federation launched
- 2004 Conducting the All-Russian Working Conference at the Health Ministry of the RF that tackled issues of medical and social rehabilitation of disabled people with MS
- 2004 Participation in Parliamentary Hearings at the State Duma of the RF, in the forum of the Federation Council, in the meeting of the MS International Federation (MSIF), in Public Hearings on budget development in 13 regions of the RF
- **2005** Engaging in the work of the Committee on healthcare issues at the Public Chamber of the Russian Federation

ACHIEVEMENTS

180 million rubles (5 million euro) was allocated on target regional programmes developed on the initiative of the All-Russian MS Society throughout the RF in 2001-2005.

With the participation of the All-Russian MS Society, the RF Government and State Duma have allocated 99 billion rubles (2.8 billion euro) to treat patients with chronic disabling diseases for the period of 2008-2010.

In 2010, Plenipotentiary Public Experts (PPEs) delegated by the All-Russian MS Society take part in developing regional lists of people with MS and controlling the federal budget financing of the pharmaceutical provision in 75 regions. Nurses work in 55 regions of the RF.
